Key Points:

- 1. Assets are at \$6.8 million at the end of October. This figure is comprised of \$6 million in cash and approximately \$674,000 in accounts receivable.
- 2. Liabilities are \$521,000 at the end of October. This balance is primarily for contract services due to FCCC. Equity is at \$6.2 million.
- 3. For October 2021, total revenues are \$673,000 and total expenses are \$524,000, for a net profit of \$149,000. This is \$90,000 better than the budgeted profit for October of \$59,000.
