






August Trend for Past 5 Years








Average # of Filings Per Hour in August








Submissions to Correction Queue in August








Average Number Days to Docket in August

Department of Revenue Re-direct and Termination Documents

6,607 Re-direct and Termination documents were sent to the Counties by the Portal. The Portal takes the daily DOR data file, creates the appropriate documents, uses the depository number to search CCIS for the correct UCN and then distributes appropriately. These documents are no longer being sent to the Counties in a paper format.






