Overview

Within 24 hours after the court issues an injunction for protection against domestic violence, the clerk of the court shall electronically transmit a copy of the petition, financial affidavit, Uniform Child Custody Jurisdiction and Enforcement Act affidavit, if any, notice of hearing, and temporary injunction, if any, to the sheriff or a law enforcement agency in the county where the respondent resides or can be found, who shall serve it upon the respondent as soon thereafter as possible on any day of the week and at any time of the day or night. HB905

The Portal was asked to provide a secure filing path for clerks to accomplish the directive of the Legislature stated above. This filing path is available for all clerks to use however it is not mandatory.

Configuration/Setup

Security Roles

The following security roles have been created in the Portal.

- 1. Can Send Injunction Packets to Law Enforcement
- a. Assigned to clerks who can send Injunction Packets to Law Enforcement
- 2. Can Receive Injunction Packets
 - a. Assigned to users of the virtual organization "Injunction Packets (docs) to Law Enforcement for Service" that can receive Injunction Packets from the Clerks.
 - b. These are Law Enforcement officers that Clerks are searching for and selecting from the "Law Enforcement" page.
- 3. Receive Injunction Packet Not Downloaded Alert(s)
 - a. Assigned to users of the virtual organization "Injunction Packets (docs) to Law Enforcement for Service" that can receive email alerts when an Injunction Packet is not downloaded with a specified period of time.

Docket Codes

- 01 Petition
- 02 Financial Affidavit, if any
- 03 UCCJEA

- 06 Certified copy of the Injunction (which is served upon the respondent)

Injunction Packet Filing Path

Created a new filing path "Send Injunction Packet (docs) to Law Enforcement for Service." This filing path is only accessible to clerk users who are assigned a security role of "Can Send Injunction Packets to Law Enforcement." This filing path is like other agency filing paths in that the documents are sent to the agency (example Department of Corrections).

Clerks can access this page as an authorized Clerk Filer from the RAC Client by going to the Main Menu \rightarrow Clerk Filing Options \rightarrow Send Injunction Documents.



You can access this page as an authorized clerk filer from the filer's interface (Single Session Web Site" by going to Main Menu \rightarrow Filing Options \rightarrow Send Injunction Documents.



Case Information Tab

This is like the case information tab in the Pleading on Existing Case filing path with the "Emergency Filing" option removed.

Documents Tab

This is like the documents tab in the Pleading on Existing Case filing path. Filers can add/remove/update documents.

Law Enforcement Tab

This page allows the clerk filer to select the Law Enforcement officer(s) that will receive the Injunction Packet for service upon the respondent.

Review and Submit Tab

This tab is like the Review and Submit tab for the Pleading on Existing Case filing path with areas that are not applicable removed.
