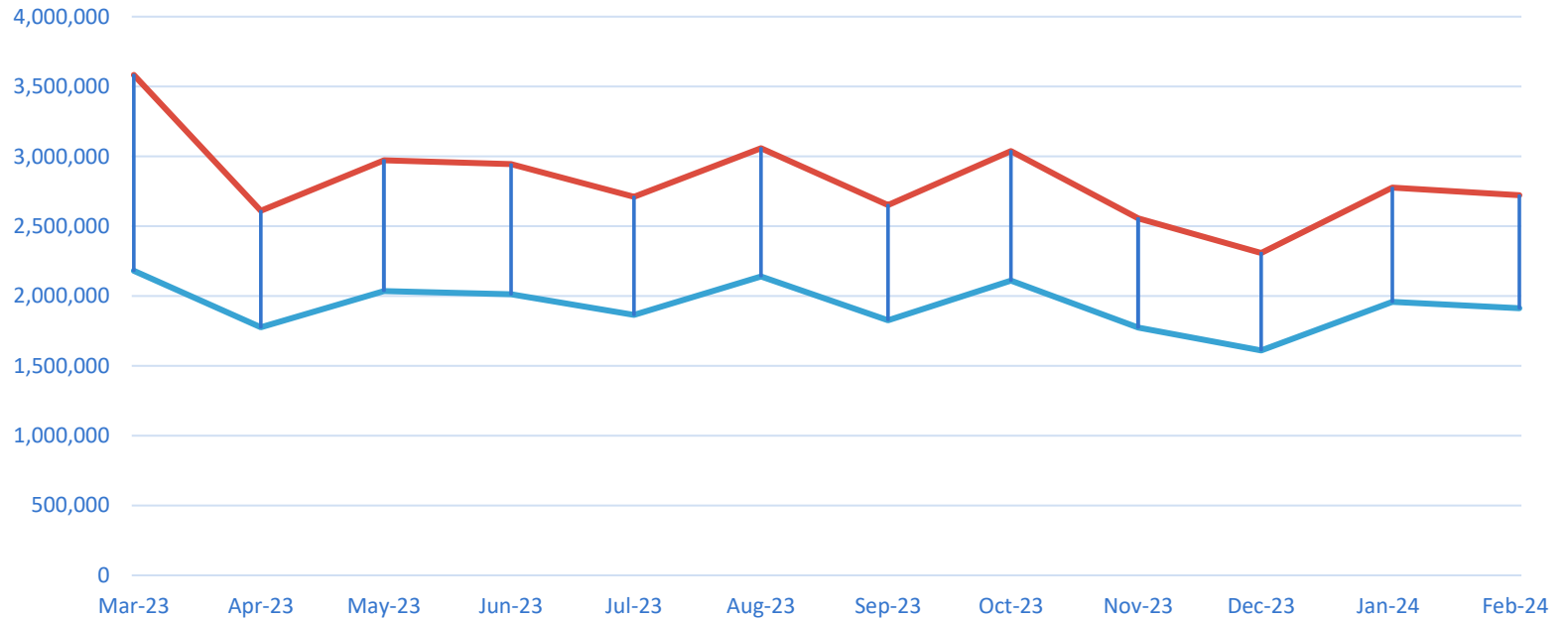

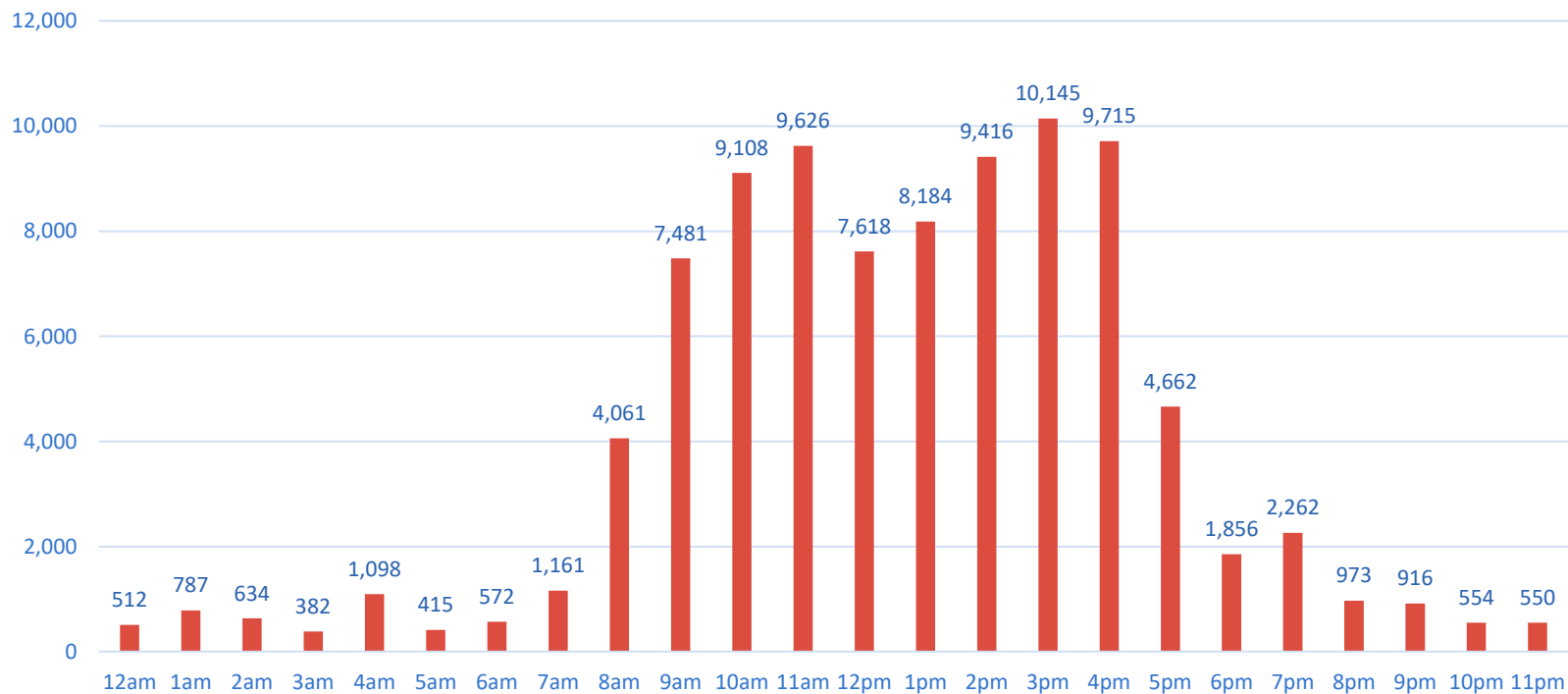

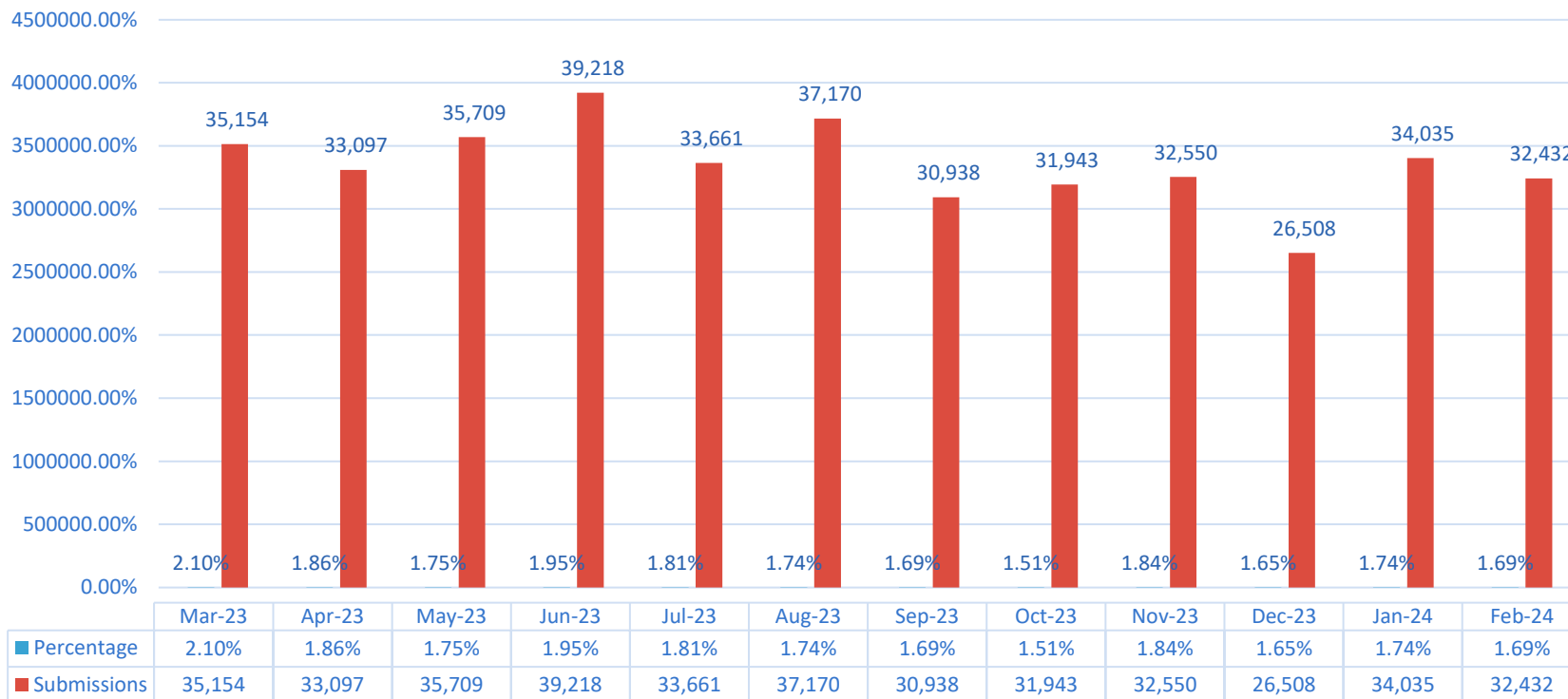

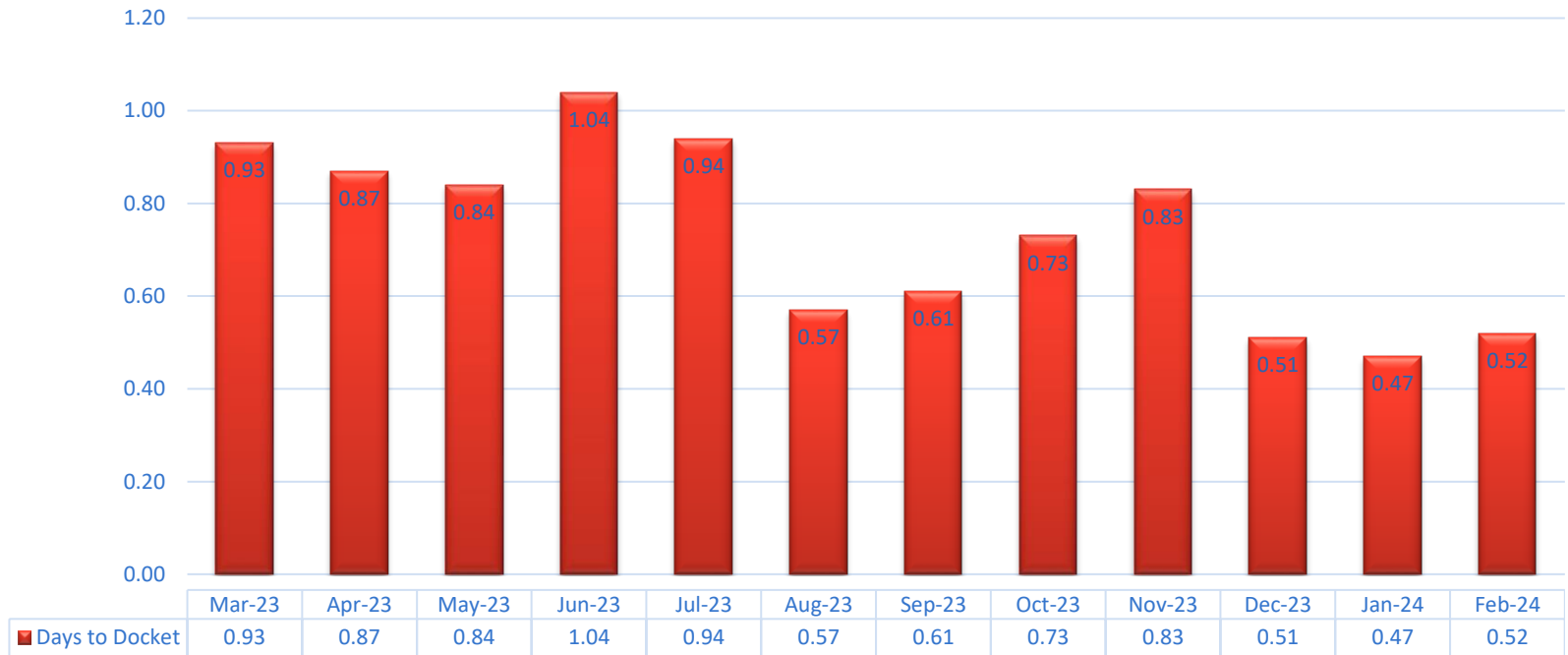
February Average # of Filings Per Hour



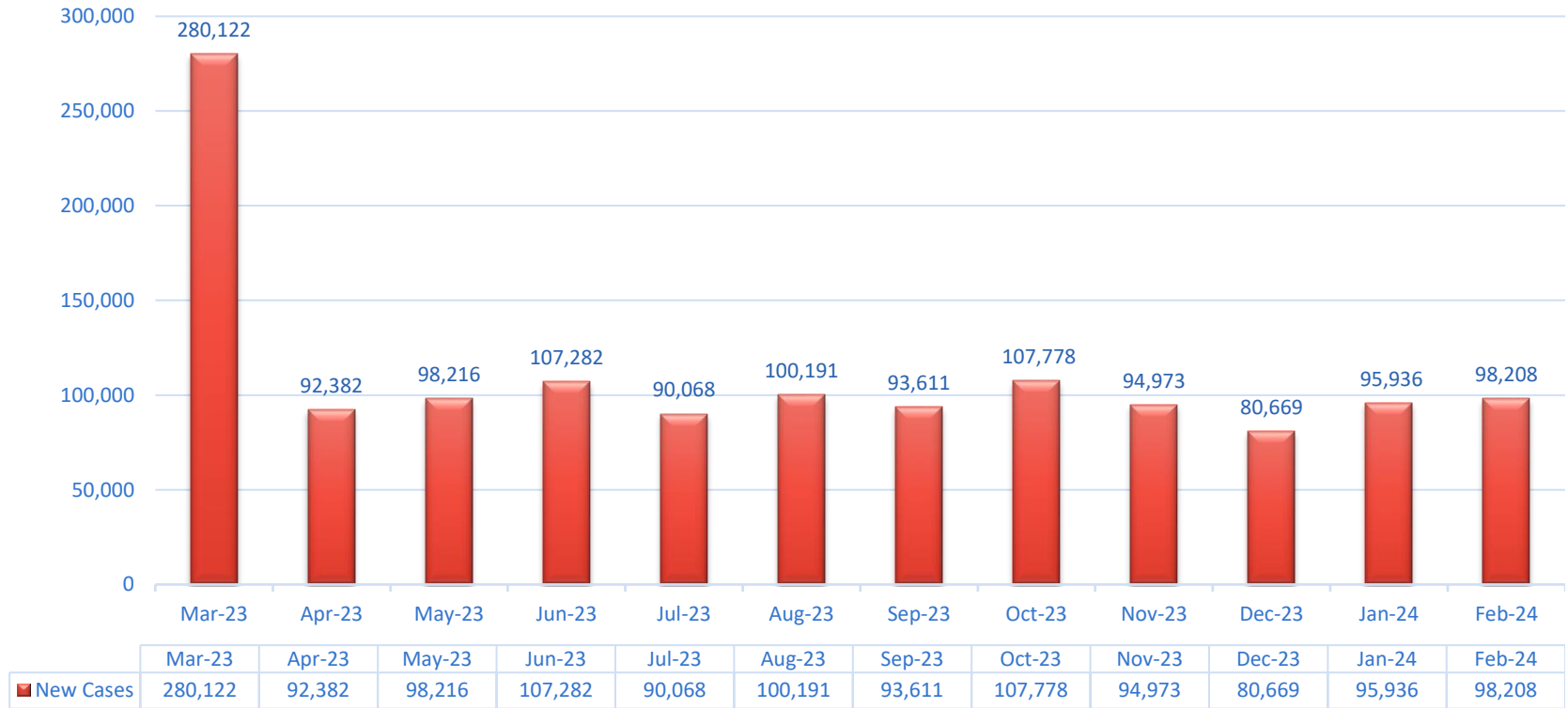
February Submissions to Correction Queue

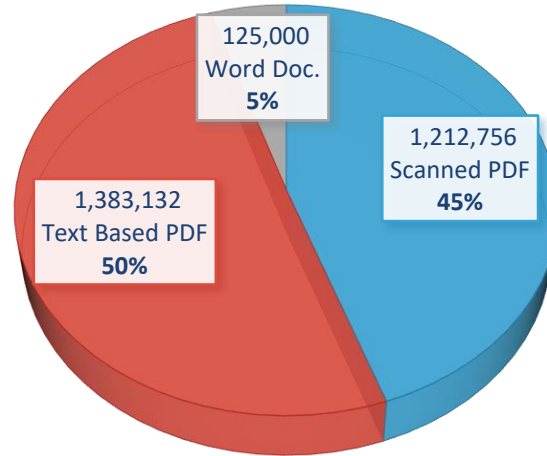

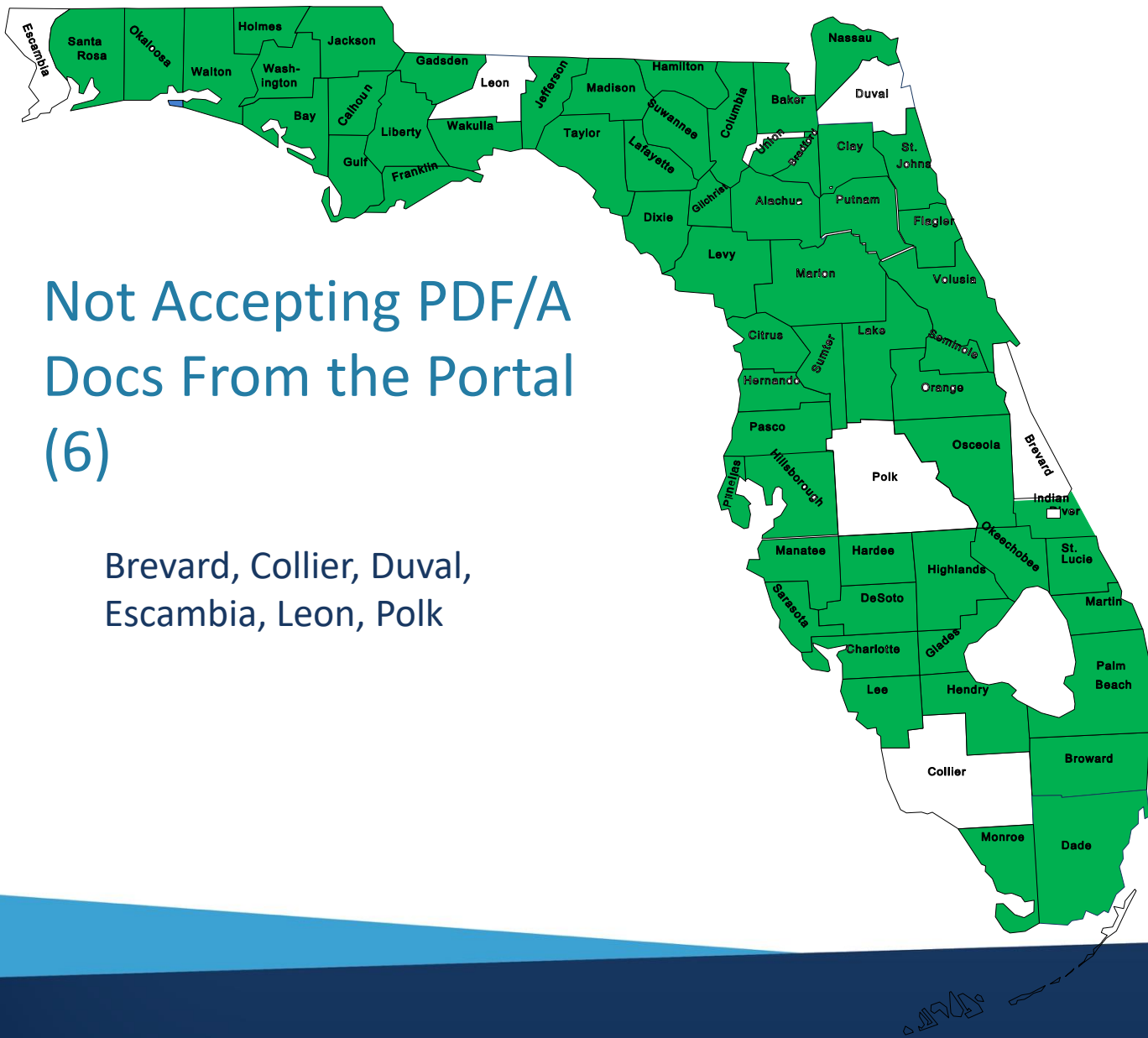

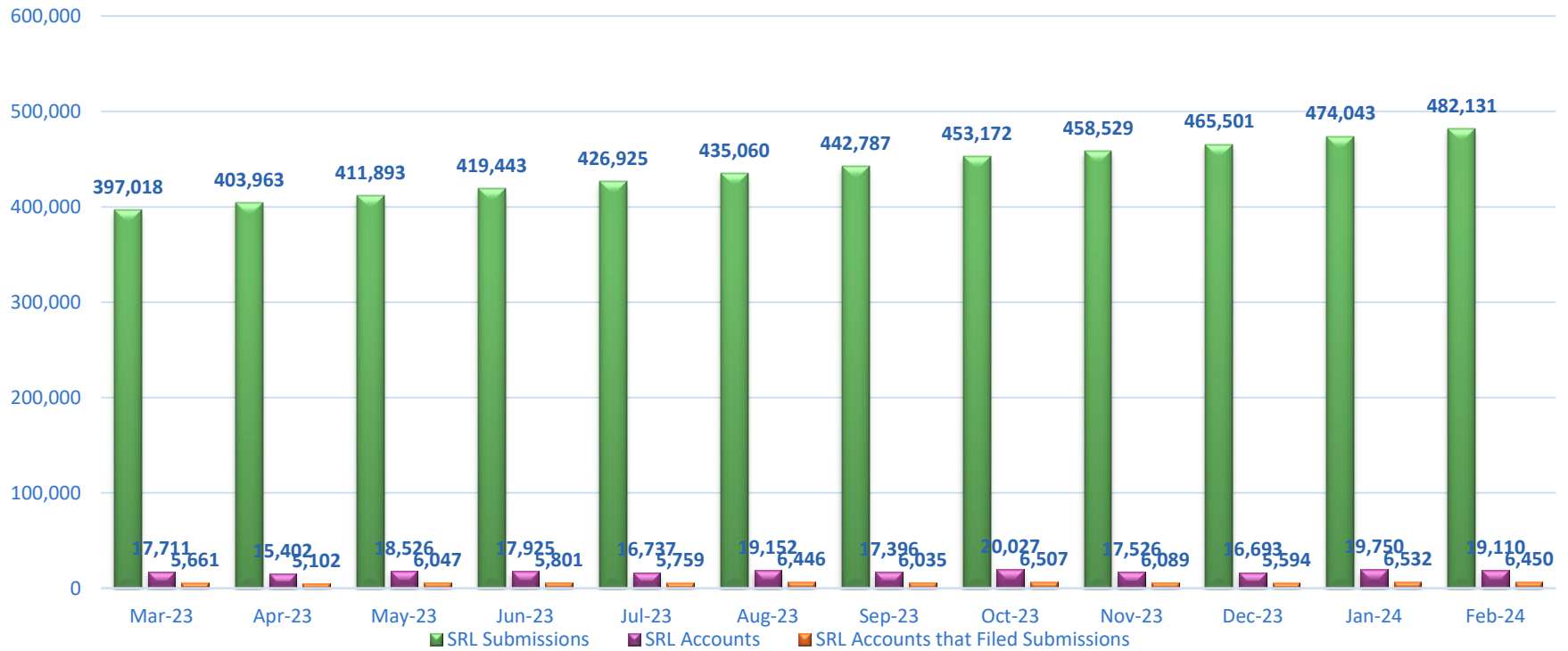
