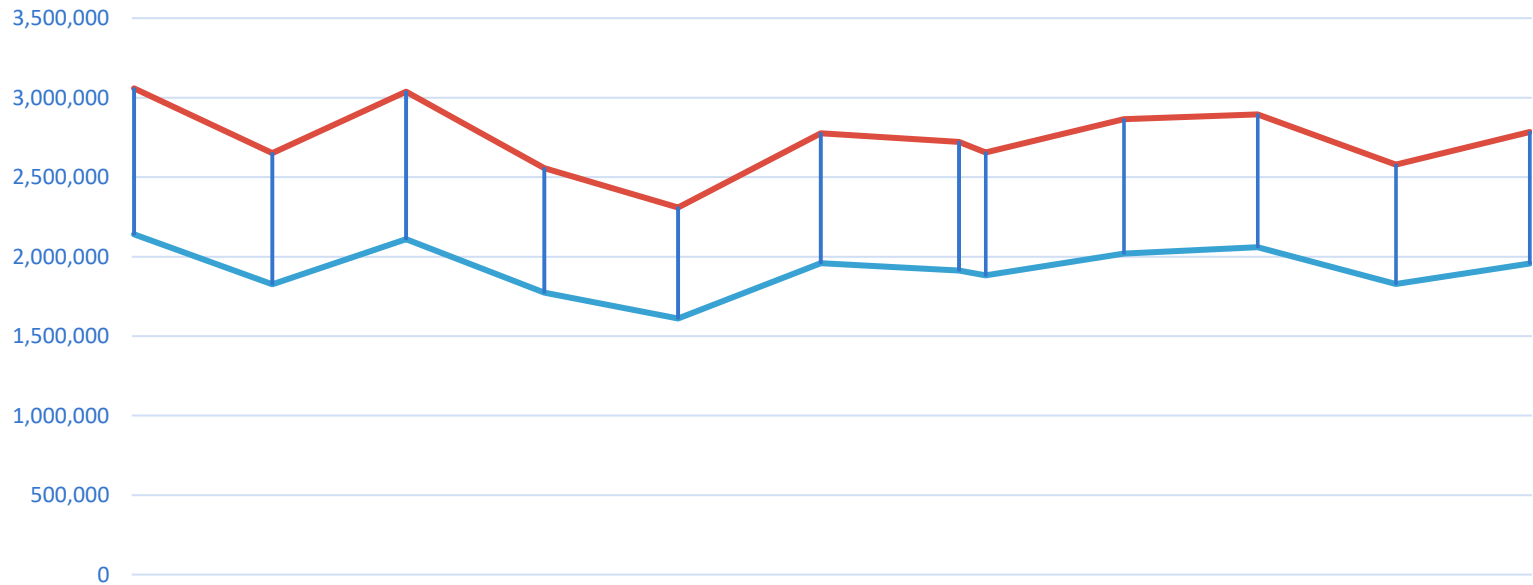

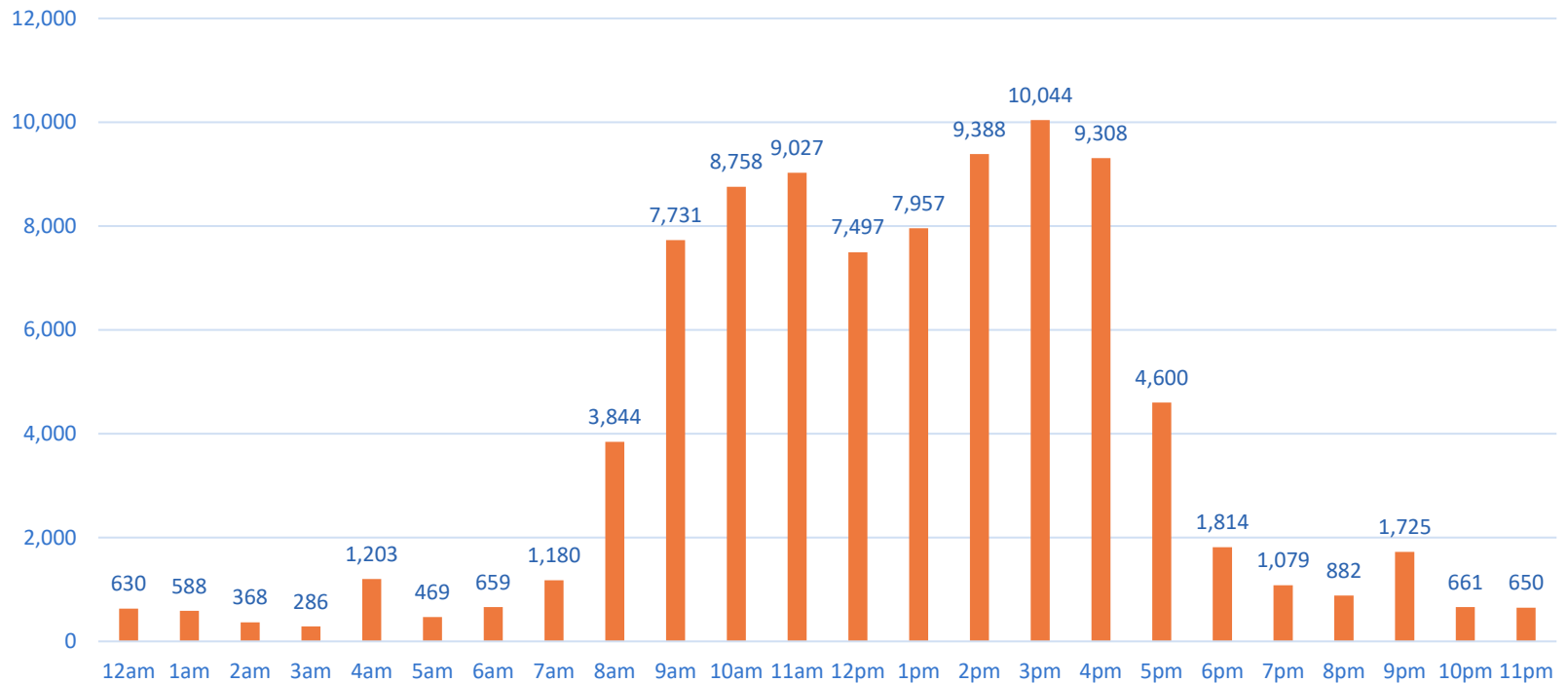

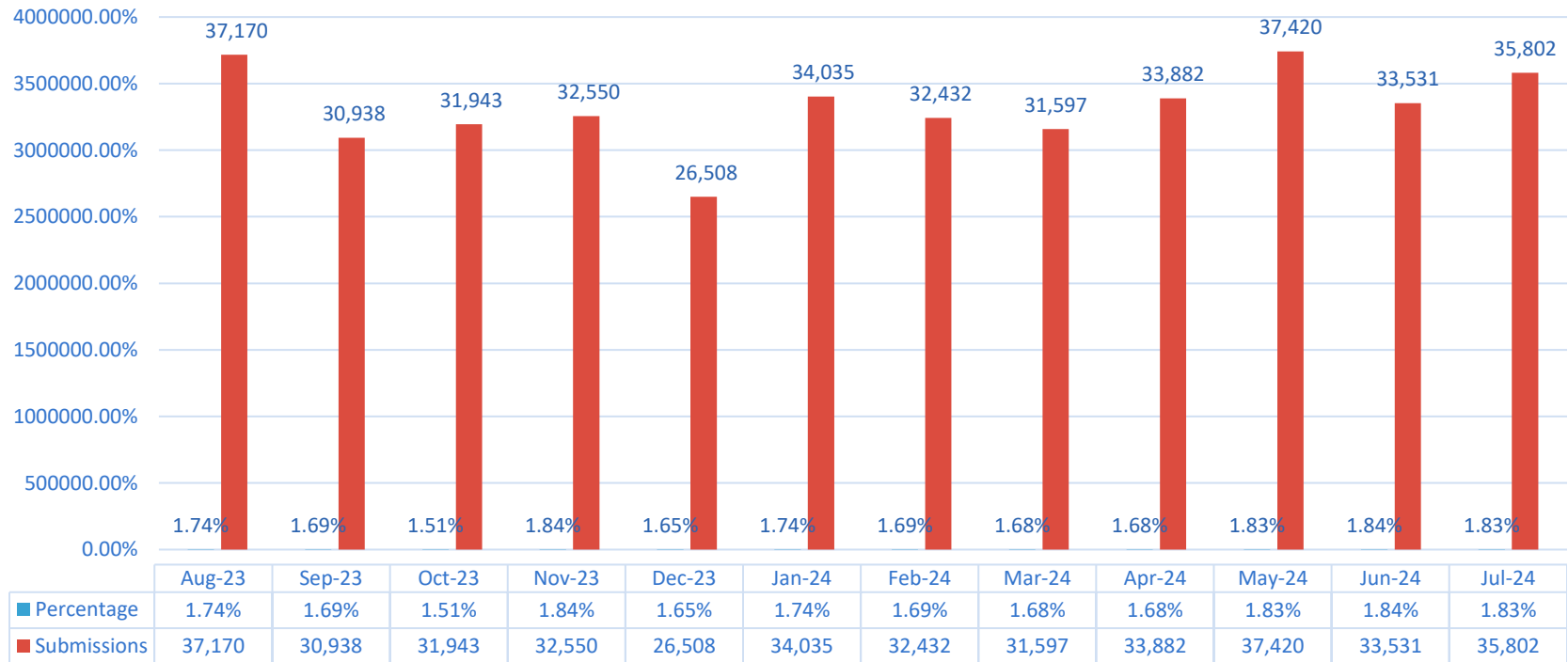
# Year at a Glance



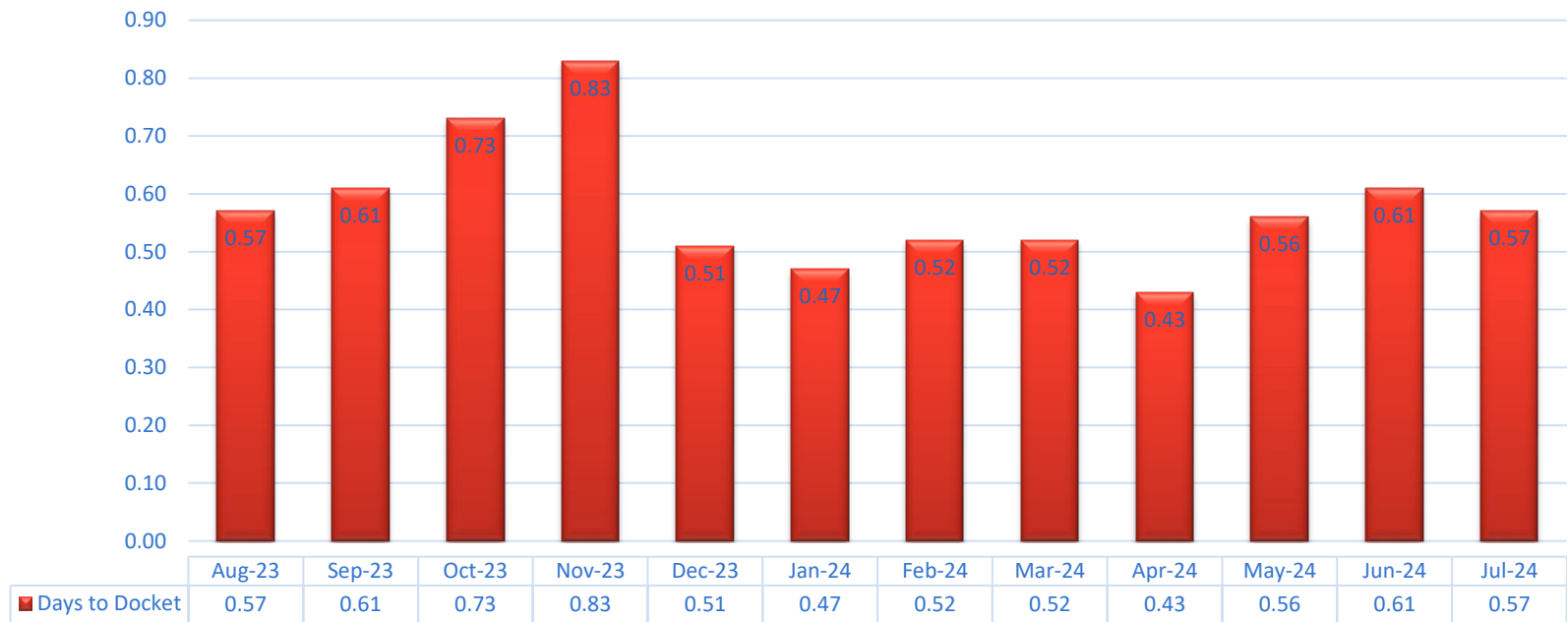
# July Average # of Filings Per Hour



# July Submissions to Correction Queue

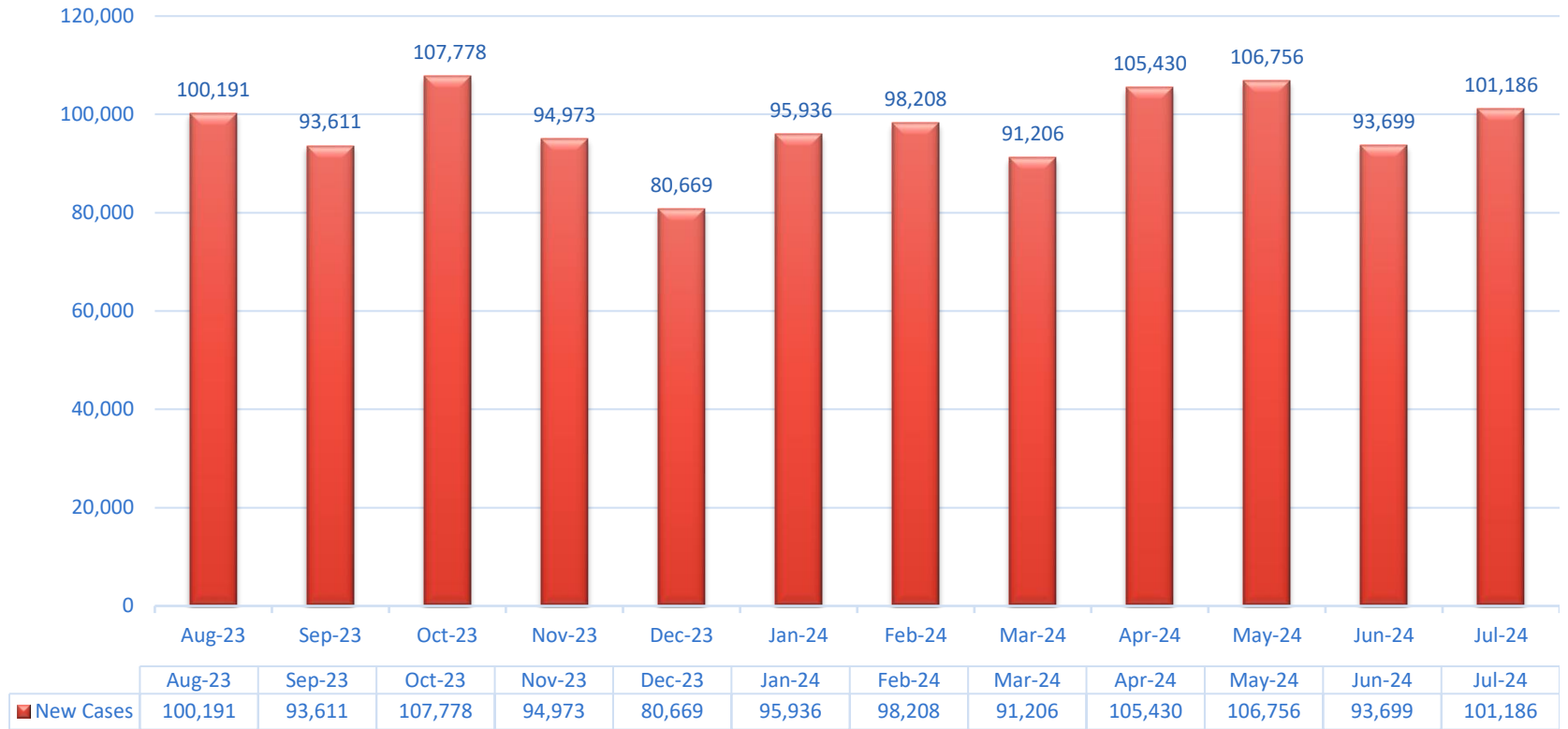


# July Average Number of Days to Docket

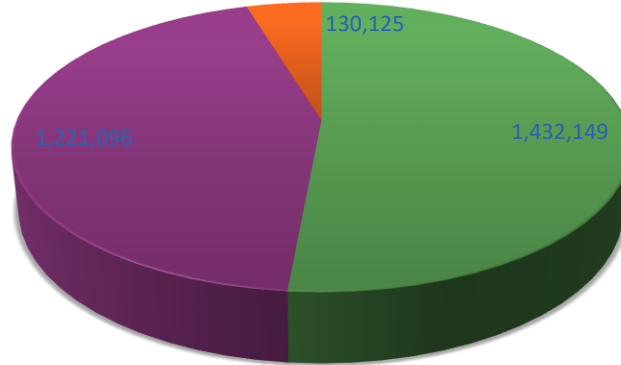

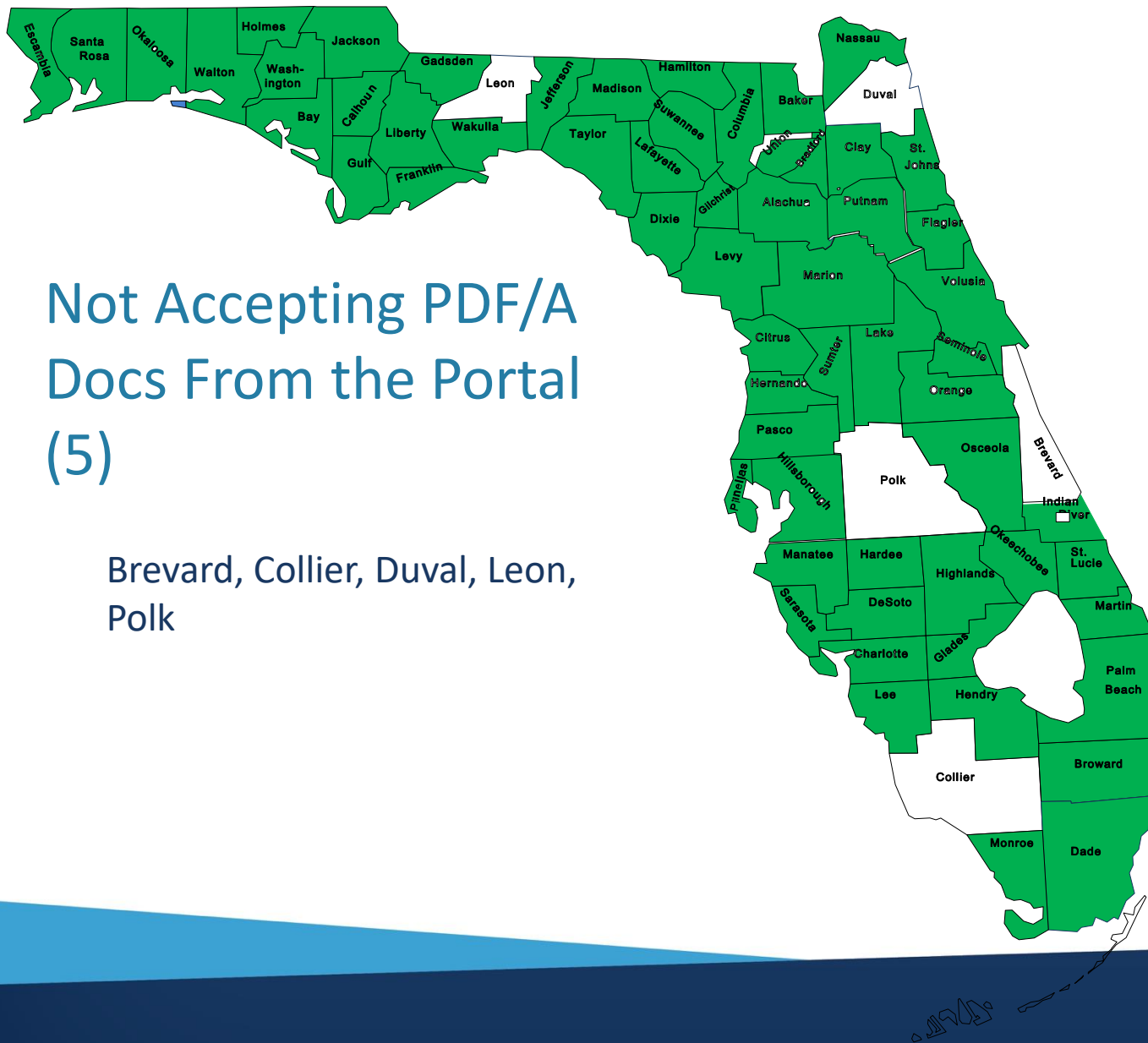

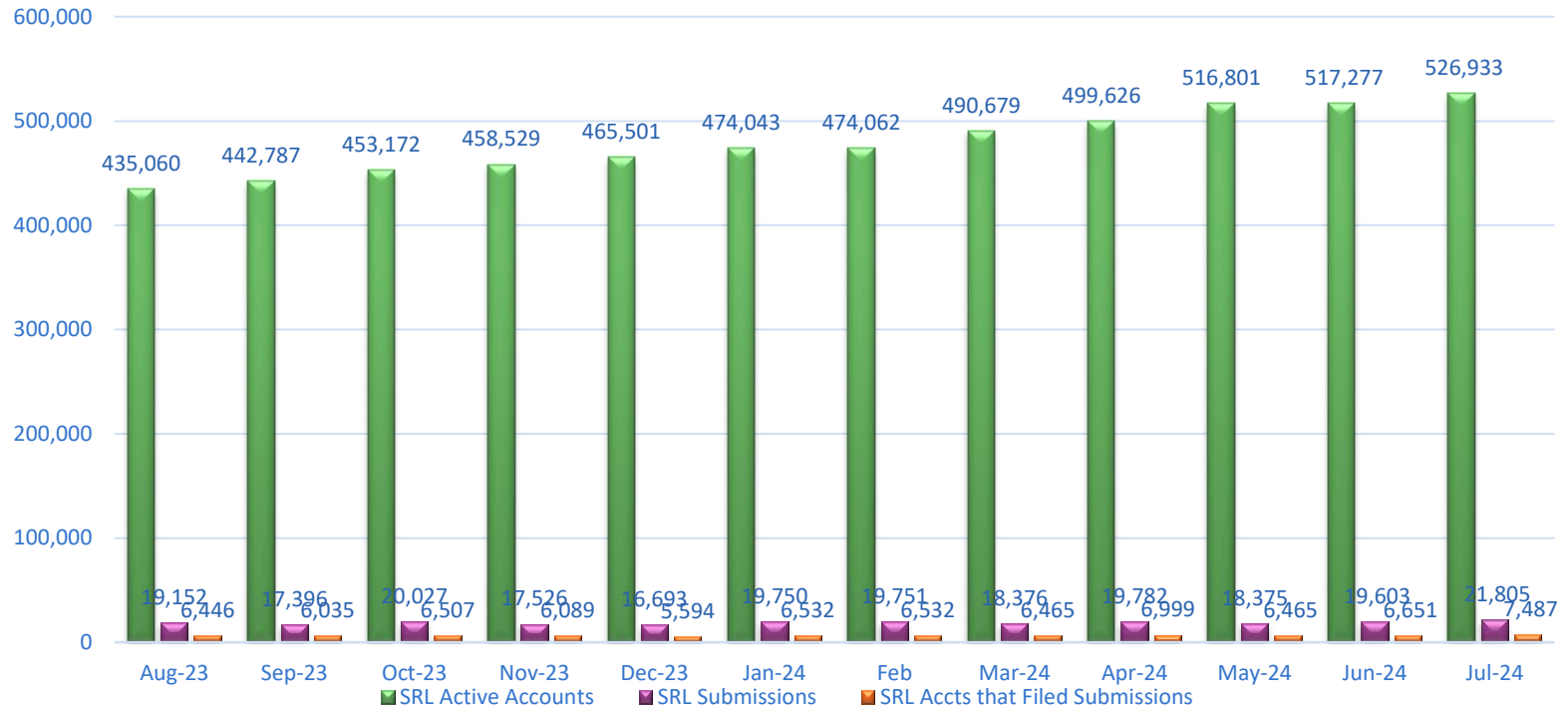
